A BYLAW respecting rental fees for
Shadbolt Centre for the Arts

The Council of the City of Burnaby ENACTS as follows:

1. This Bylaw may be cited as BURNABY SHADBOLT CENTRE RENTAL FEES BYLAW 1998.
2. Burnaby Parks and Recreation Commission may charge for the use of facilities at the Shadbolt Centre for the Arts the fees specified in Schedule "A".
3. Burnaby Art Centre Rental Fees Bylaw 1997, Bylaw No. 10616, is repealed.
4. This Bylaw comes into force on the first day of September, 1998.
