

**CITY OF BURNABY**

**BYLAW NO. 13908**

A **BYLAW** to provide special voting opportunities for the 2018 general local election and other voting

WHEREAS section 109 of the *Local Government Act* empowers the Council by bylaw to provide special voting opportunities in order to give electors who may otherwise be unable to vote an opportunity to do so;

AND WHEREAS the general voting day for the 2018 general local election is October 20, 2018;

NOW THEREFORE the Council of the City of Burnaby ENACTS as follows:

1. This Bylaw may be cited as **BURNABY SPECIAL VOTING OPPORTUNITIES BYLAW 2018.**
2. Only electors who are residents or patients of a special voting place specified in sections 3 and 4 of this Bylaw may vote at the special voting place.
