BYLAW NO. 11332

A BYLAW to set fees payable for processing liquor licence applications

(Consolidated for convenience with Bylaw 11483, 11668, 11848, 12037, 12186, 12372, 12548, 12727, 12885, 13043, 13166, 13267, 13415, 13539, 13663, 13794 and 14500)

The Council of the City of Burnaby ENACTS as follows:

- 1. This Bylaw may be cited as **BURNABY LIQUOR LICENCE APPLICATION FEE BYLAW 2001**.
- 2. Where the City is requested to comment on an application for the issue, amendment or renewal of a licence under the Liquor Control and Licensing Act, the applicant shall pay to the City the fee set out in the Burnaby Consolidated Fees and Charges Bylaw to this Bylaw. (BYLAW 13794, 14500)
- 3. This Bylaw shall come into force on the first day of January 2002.
