**BYLAW NO. 13640**

A BYLAW to establish a fee for recovery of credit card merchant fees

(Consolidated for convenience with Bylaw No. 14012 and 14492)

The Council of the City of Burnaby ENACTS as follows:

1. This Bylaw may be cited as **BURNABY CREDIT CARD MERCHANT FEE RECOVERY BYLAW 2016.**
2. Except as set-out in section 3 of this Bylaw, the fees and charges payable to the City departments set-out in Column 1 of Schedule A may be made by credit card and where payment is made by credit card, a non-refundable fee as specified in the Burnaby Consolidated Fees and Charges Bylaw shall be paid to the City in addition to the applicable fee or charge. (BYLAW 14492)
3. Payment by credit card is not permitted:
  - (a) for the items set-out in Column 2 of Schedule A; and
  - (b) for any single fee or charge that exceeds the amount as specified in the Burnaby Consolidated Fees and Charges Bylaw. (BYLAW 14492)
